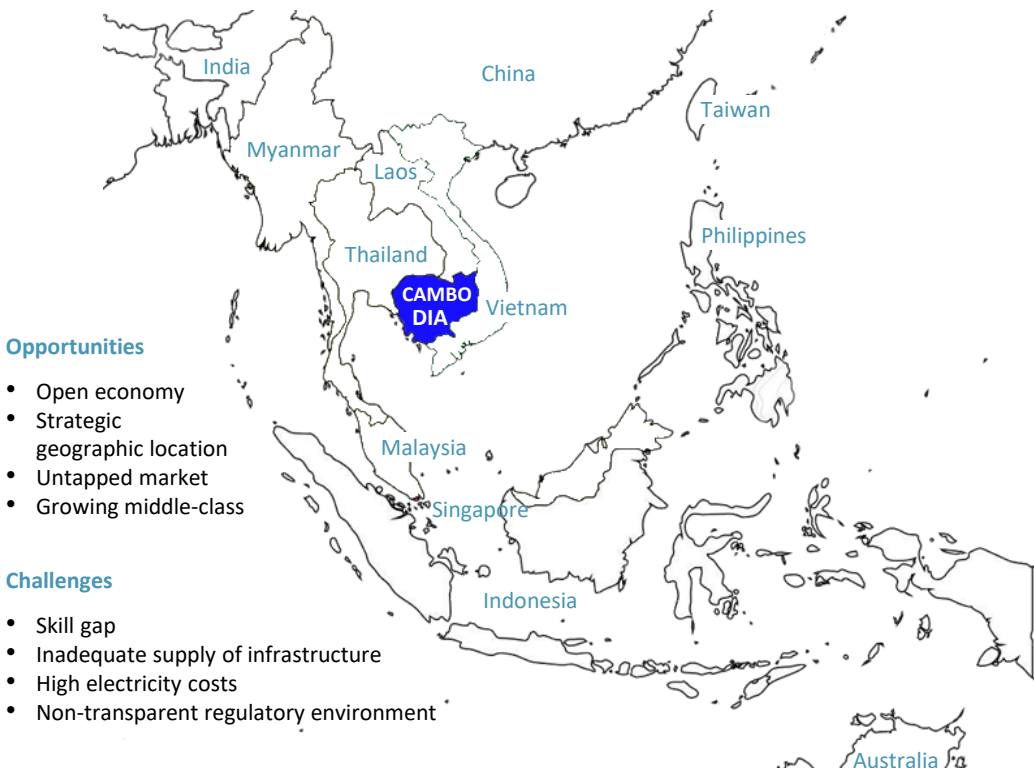

- Annual growth rate of 7%

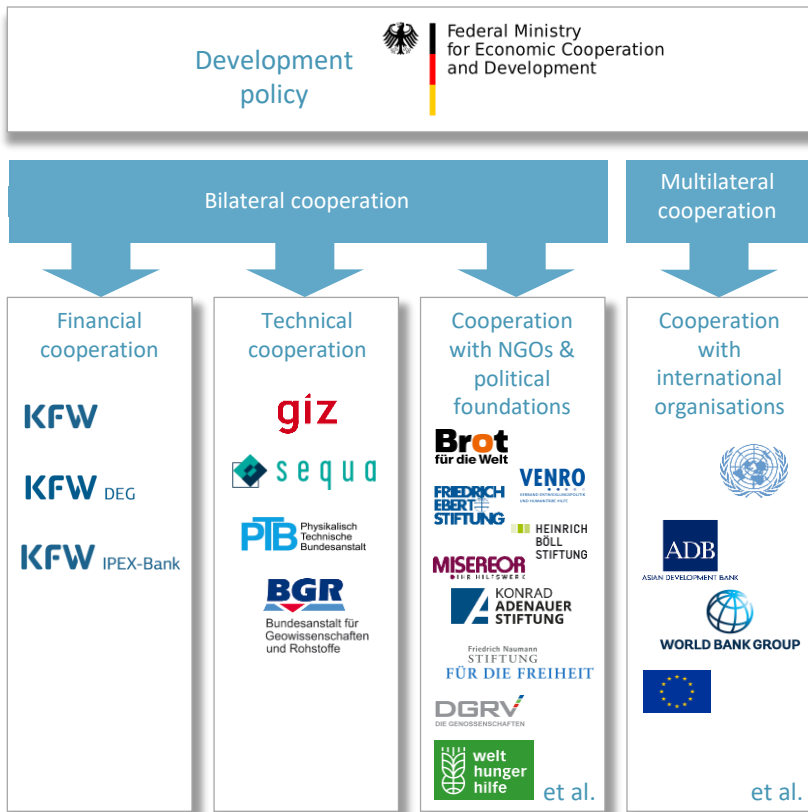

German development policy is defined by the Federal Ministry for Economic Cooperation and Development (BMZ). Germany supports many multilateral organisations. Additionally, several governmental agencies and non-governmental organisations implement bilateral programmes.

2.2 Implementing agencies

The Kreditanstalt für Wiederaufbau (KfW) is one of the world's leading promotional banks. 3 Support services for the private sector

German development cooperation has steadily increased its efforts to integrate private sector activities into its work and has therefore set itself the objective of establishing closer links between foreign trade, private sector and development cooperation activities. To this end, it has developed a wide range of support and financing opportunities to facilitate business involvement in development cooperation.

Through its implementing agencies, German development cooperation has established a presence in over 130 developing and emerging countries. These agencies supplement the work of Germany's embassies and the international network of Chambers of Commerce.

In September 2018, EuroCham and the German Business Group Cambodia (Arbeitskreis Deutsche Wirtschaft - ADW) signed a memorandum of understanding (MoU) with GIZ, one of Germany's development cooperation implementing agencies, to formalise cooperation within the Global Business Network Programme (GBN). The GBN Cambodia provides information, advice and guidance to support local, German and other European businesses and institutions in engaging in development cooperation.

Pilot projects

develoPPP

What is supported?

- Sustainable pilot investments in which development objectives and business interests match, e.g. improvement of environmental, social and quality standards, value chain development, qualification and training, improvement of resource and energy efficiency (funded by the Federal Ministry for Economic Cooperation and Development - BMZ)

What do GIZ/ DEG offer?

- Financial or technical support
- 100K EUR to 2 million EUR (min. 35% of the project cost, normally 50%)

Who can participate?

- German and other European companies, companies in developing and emerging countries

How to apply?

- develoPPP.de ideas competitions at the end of each quarter
- DEG/ GIZ assess the projects
- DEG/ GIZ + companies develop a detailed project concept

Criteria for projects	Criteria for companies
• Compliant with development objectives and go beyond the company's bottom line	• > 800K EUR annual turnover
• Public and private resources and funds should complement each other	• > 8 employees
• Subsidiarity: Without the public contribution the project will not be implemented	• At least 2 operative business years
• Sustainability: The project is part of the company's long-term involvement in the target country	
• Private sector contribution: recognisable commercial interest of the company; company has to contribute at least 50% of total costs (cash and/ or in-kind)

Project Development Programme (PDP)

What is supported?

- The Project Development Programme (PDP) supports German suppliers of climate-friendly energy solutions. It is implemented by GIZ within the scope of the German Energy Solutions Initiative

Who can participate?

- German suppliers of climate-friendly energy solutions entering rapidly growing markets in developing and emerging countries
- Clients or customers in target countries

What does PDP offer?

- In cooperation with other GIZ projects and German Chambers of Commerce abroad, PDP offers a wide range of free services
- *Information:* national policies, regulations, market potentials, solar technologies, financing models
- *Project development:* technological and financial feasibility
- *Preparation of tender documents* according to international standards
- *Find business partners* in Germany

Finance

Corporate finance - loans, equity, mezzanine finance

Long-term loans

- Currency: Euro or US Dollar, in certain cases local currency
- Term: generally between 4 and 10 years
- Collateral: usually as the company's fixed assets in the country of investment
- Interest rate: fixed or variable, market-oriented depending on project and country risks
- Structuring: tailor-made and according to the customer's requirements

Equity investments

- Equity participation in the company in the country of investment
- As a rule with a minority stake
- Variable structuring of risk components

Mezzanine finance

- Financing form between equity capital and debt capital
- Project-specific structuring
- Subordinated collateral
- Term: generally 10 years, but also longer
- Risk-appropriate return

KFW DEG

Business Support Services (BSS)

What is supported?

- Non-repayable co-financing for projects aiming to improve companies' performance, growth, and to enhance sustainability with respect to commercial, social and environmental best practices

Who can participate?

- Prospective and existing customers

What does DEG offer?

- Conceptual and financial assistance, corporate governance, risk/ social/ environmental management, strategy, resource and energy efficiency, training of staff and suppliers

Objectives

- Support the expansion of rice processor Angkor Rice as buyer of rice and generate income for local farmers as suppliers
- Use waste product "rice husks" for renewable energy generation

Finance

Upscaling Programme

What is supported?

- DEG finances investments of SMEs to scale up innovative business models
- Companies between microfinancing and traditional financing

What does DEG offer?

- Funding of 500,000 EUR, max. 50% of total investment volume
- Private companies must contribute a substantial share of equity (min. 25%)
- DEG's funds must be repaid in the event of success of the investment

Who can participate?

- Early-stage SMEs registered in a developing or emerging market
- Local subsidiaries of German or European companies

How to apply?

- Proposals to DEG at any time

Co-financing of feasibility studies

What is supported?

- DEG co-finances feasibility studies
- Planned investment must have development relevance

Who can participate?

- German and other European SMEs with an annual turnover < 500 million EUR
- Proposing company financially capable to carry out planned investment

What does DEG offer?

- DEG provides max. 50% of the costs for each feasibility study < 200,000 EUR
- Proposing company covers min. 50% of the costs for the study

How to apply?

- Companies can submit their proposals to DEG at any time

What do the German Desks offer?

- Close link between local banks, the local business community, the German Chambers of Commerce abroad and DEG's representative office on the ground
- German Desks help to bridge cultural and language gaps
- Serve as a bridge for financing solutions
- Setting up accounts, services for financing trade & transaction banking, credit lines/ investment financing for local companies
- German Desks in Lagos/ Nigeria, Nairobi/ Kenya, Dhaka/ Bangladesh, Jakarta/ Indonesia and Lima/ Peru

Senior Expert Service

What is supported?

- The Senior Expert Service seconds specialists who are either retired or on a leave of absence for worldwide voluntary assignments to private companies, governmental and non-governmental institutions

Who can participate?

- Small and medium-sized companies, public authorities, professional and business associations, social and medical facilities, institutions providing basic education or vocational training

What does SES offer?

- SES has more than 12,000 experts with expertise in more than 50 sectors of industry who provide advice and hands-on support nearly all around the world
- Their volunteer assignments usually last 3 - 6 weeks; max. duration: 6 months
- Project handling costs, additional costs, cost of international travel
- Local expenses to be paid for by applicants

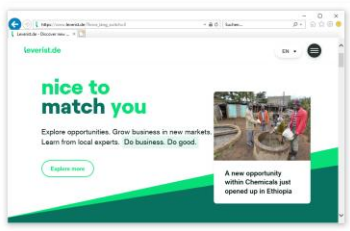
