Our main products:

- Cashew nuts: unroasted, roasted, natural and flavored cashew kernels, broken cashews, cashew milk, cashew cheese for local markets and for export
- GI-certified Kampot Pepper (black, red, white, green, salted), for export and for local marketing
- Organic pepper (black, red, white, green, salted), for export
- Long Pepper for export and for local marketing
- Lemongrass tea and powder for export and for local marketing
- Banana sugar for export and for local marketing
- Palm sugar for export and for local marketing
- Moringa tea, powder tablets
- Tea mixtures (moringa, pepper (vines), turmeric, lemongrass)

The products for which packaging solutions are required are the spices, tea, (moringa) tablets, sugar; and also the cashew milk and cashew cheese.

Our general requirement is a certification for food safety and material that can either be recycled or composted or at least is produced and discarded with minimum environmental impacts. We would appreciate any advice we could get in adapting our packaging to latest, affordable solutions with minimum environmental impact/footprint. Happy to work not only with a "producer" but also with a "distributor/agent" of a respectively experienced company from abroad.

Our business:

We process, package, sell locally and export certified-organic cashew nuts, pepper, long pepper, lemongrass, turmeric, moringa, palm sugar, banana sugar and other products which are grown on our own farm or which we buy from other certified producers. The trading business is running for 7 years already, own production started in 2016, processing, i.e further downstream activities have started only recently but are expected to become a key area of activity to retain value addition in the country and respond to an increasingly quality conscious demand for organic and health food.
